

## **AFFIDAVIT**

1. That, I am a citizen of India and a permanent resident of the aforesaid locality.
2. That, I am participating in the INDIA – MYANMAR – THAILAND Friendship Car Rally, 2014, organized by the North East Federation on International Trade (NEFIT), India and supported by Govt. of India, Govt. of Thailand and Govt. of Myanmar.
3. That, I shall abide by the laws of India, Myanmar and Thailand and any other international law(s) as the case may be.
4. That, I shall abide by the terms and conditions of the organizer(s), i.e., North East Federation on International Trade (NEFIT).
5. **INDEMNITY & DECLARATION:** That I have read the Regulations issued for this event and agree to be bound by them.
